WHEREAS, Ms. Seko possesses professional certification as Childhood Education (Grades 1-6); and Students with Disabilities (Grades 1-6);

NOW, THEREFORE, BE IT RESOLVED, that upon the Superintendent's recommendation, the Board hereby appoints Ms. Seko, in accordance with §3012 of the Education Law, to a four-year probationary term, in the Elementary tenure area, commencing on September 1, 2015 and ending on August 31, 2019; except that to the extent required by Education Law §3012, in order to be eligible for tenure at the end of the probationary term, Ms. Seko must have received composite or overall APPR ratings pursuant to Education Law §3012-c and/or §3012-d (as applicable) of either effective or highly effective in at least three (3) of the four (4) preceding years, and also must have received an effective composite or overall APPR rating in the final year of the probationary period, or she shall not be eligible for tenure at that time; and BE IT FURTHER RESOLVED that nothing in this resolution shall be construed to limit the unfettered statutory right of the school district to terminate Ms. Seko for any statutorily and constitutionally permissible reason while she remains in probationary status.
